1. Dear Sir, on 8th June 2020, I received a call from TNE Solutions Fraud Company from 9956224783 for work from home job of entering 10,000 captcha for 10 Days.
2. They offer a job of entering 10000 captcha within 10 days.
3. If not completed within time or accuracy is less than 90% then I have to pay penalty of 5400.
4. On 9<sup>th</sup> June 2020, They send me an agreement link from dept8336@gmail.com. following is the agreement link. <http://agreementweb.in/Agreement.php?id=OTgwMzMzMyNjA3MQ==> which digitally signature required. Even the agreement has no letter head and no company Name on the TOP.
5. I have seen and read the full agreement thoroughly. I haven't accepted and haven't signed the agreement. They have signed of their own. When I click over the agreement it's disappeared and message shown that you are successfully registered.
6. On the same day, I have reached the review of this work from home on Cyber Crime Site. Lots of complaint has been Logged against this Fraud Company. So I have decided to discontinue that agreement with this fraud company from immediate effect from today. Which was totally fake?
7. The Company doesn't have any proper website, where we can find the address and Products and offers of their work. They are working only on the Links and makes the people fool.
8. They threaten the people and takes lots of money after by using threatening words like your case will give to the Legal and a legal notice will be sent to the police.
9. I took advice from my friend also but he also told me not to take the work and told me leave this work now.
10. Then I have sent the cancellation mail to the HO of this company, that I have no interest in your work, please cancel it.
11. On 11<sup>th</sup> June 2020, I received a threatening messages from contact no 8758573812 on my WhatsApp no. and through mail of demand of money immediately within an hour for cancellation of the work agreement from this fraud company. She Mentally Harassed me to give the money immediately.

12. They demand me of money Rs.5400/- immediate pay within an hour and call/messaged continuously, and told me your case file will go to the Legal and a legal notice will be issued against you. I was going in very deep depression due to this threatening messages and Calls.
13. I have paid the same amount due to I was going in deep depression and mentally heressed by her. I was seem like dead due to the threatening messages from this no. 8758573812 on my Whatsapp No.
14. After One day, On 13<sup>th</sup> June 2020 Saturday, then another threatening messages from the Contact no.7265862653 has come on my Whats App no. When I ask him from where you are, he told me he is from NOC Dept. He was not picking the call and sent me threatening messages on my WhatsApp number. Even when I call him, his number was going busy and ignoring to accept the call on WhatsApp Calling and used very rude and abused language. He sent threatened messages on my Whats App no and told me to pay for whole agreement 5400\*11months'i.e Nearly 60000/- Rs. pay immediately within an hour, otherwise your case file will go to the Legal and threatening of mail of legal has sent on my mail. Then I told him to send me the agreement, when I have seen the agreement they have done a false digital signature of their own.
15. After that he sent me a mail to make payment of Rs. 28950/- to the court. This is to intimate and final
